The different types of gifts

There are **three types** of gift you can leave in your Will:



A residuary gift

This is a **percentage of your estate** once any specified gifts have been made to friends and family. Many of our supporters choose to leave this type of gift because it does not lose value over time and they can ensure that their loved ones are well-looked after first and foremost.



A pecuniary gift

This is a **specific amount of money**. You can specify the exact sum you want to give Ovacome. However, over time, due to inflation this type of gift may lose value from the impact you originally intended.



A specific gift

This is a gift of **a specified item** – such as a personal possession, land, buildings or stocks and shares.



What should I write if I want to leave a gift?

A residuary gift

To include a residuary gift, you could use this wording: I give to Ovacome, 52-54 Featherstone Street, London EC1Y 8RT, registered charity numbers 1159682 [all / _%] of the residue of my estate absolutely for its general charitable purposes and I declare that the receipt of the proper officer at Ovacome for the time being shall be a sufficient discharge to my executors.

A pecuniary gift

To include this kind of gift, you could use this wording: I give to Ovacome, 52-54 Featherstone Street, London EC1Y 8RT, registered charity numbers 1159682 the sum of [£specify words and figures] free of tax for its general charitable purposes and I declare that the receipt of the proper officer at Ovacome for the time being shall be a sufficient discharge to my executors.

Specific

To include a specific gift, you could use this wording: I give to Ovacome, 52-54 Featherstone Street, London EC1Y 8RT, registered charity numbers 1159682 [name and description of item] absolutely for its general charitable purposes and I declare that the receipt of the proper officer at Ovacome for the time being shall be a sufficient discharge to my executors.

Inheritance Tax

Because we're a charity, most gifts to us are exempt from Inheritance Tax. In some cases, your gift could also reduce the amount of Inheritance. You can find out about other charitable tax benefits by visiting HMRC at: gov.uk/browse/tax inheritance-tax or by asking a solicitor.



Who should write my Will? Can I write my own Will?

We suggest you use a solicitor or Will-writer, though it's not necessary. But you should get your Will reviewed by a legal expert to make sure it's valid and legal. Our trusted partners offer free Will-writing and updating services.
