Planning a fundraiser

Decide what type of event you want to organise and set a realistic fundraising target. Ask for help. Speak to friends and family and Ovacome's fundraising team, who can assist with your event.

Set a date and find a venue. Think about size, facilities, transport and accessibility.

Promote your event on social media, local news stations, with posters and leaflets. Include 'who, what, when, where & why'. Keep it short and punchy.

Let Ovacome know the details of your event and we will help you set up a fundraising page on our website.

Set a budget and stick to it - always ask for charity discounts or donations of goods.

In the run up to your event, ask people in your community to donate to your fundraising page, or collect donations to send us directly.

Host/complete and enjoy your event, raising even more for Ovacome! Send in any funds raised (see how to send in your money p.10) and receive a certificate from Ovacome.



Fundraising tips



Ask us for a letter of authorisation to use as proof that you are supporting our charity when approaching organisations for raffle and auction prizes.



Personalise your fundraising page - share your story and upload photos. This can increase donations by up to 65%.



Change your email signature at work and/or at home to include the link to your fundraising page and a link to the Ovacome website, to show how your sponsorship could help people with ovarian cancer.



Start your fundraising page or sponsor form with a large donation to encourage others to follow suit.



Encourage people to tick the Gift Aid box. Gift Aid is a form of tax relief open to all UK tax payers. If you opt in, we can claim an extra 25p for every £1 you give at no extra cost to you.



Approach your workplace to see if they will match your fundraising total or make a contribution.

Set yourself a challenge: decide how many steps or what distance you'd like to walk each day, week, or month. You can even commit to simply walking every day.

Share your page with friends, family and colleagues by email and on social media.



We can supply you with any awareness and fundraising materials your need along the way! If you are going through or have just finished treatment and feel apprehensive about taking part in a sponsored walk, even a small amount of physical activity can be beneficial, reducing fatigue, poor appetite and sleeplessness. Setting a goal of around 2,500 steps per day (equivalent to 1 mile) is a reasonable target for many, although we always advise to check with your doctor before starting any type of exercise.



How to send in your money

There are 5 ways you can transfer funds to Ovacome...

CAF vouchers and other charity cheques: you must follow a different procedure for Charity Aid Foundation (CAF) vouchers. CAF vouchers will be issued to you by someone who has a CAF CAF vouchers account. cannot be paid into the event bank account and must be forwarded to Ovacome where we will process them and credit them to your event total. They must be made payable to Ovacome. Please also ensure that you write vour name and event on the back of the voucher.

By an online giving page - all the money raised by online fundraising sites including Gift Aid, will be forwarded directly to us.

By phone - we accept all credit and debit card donations over the phone. Call us on 020 7299 6651.

> By BACS transfer please contact us for our bank details.

By paying slip - Please contact us and we will post one out to you. The cash would need to be taken to any HSBC bank.

By post - please send money by cheque, postal order or CAF voucher only. Make cheque's out to 'Ovacome' and include a signed Gift Aid form if applicable. Please don't send cash.

Important DOs and DON'Ts

Here are some tips to help you out:

These notes are intended as a brief guide and the points raised may or may not apply to your particular circumstances. It is important to note that all proceeds from an event held 'in aid of' Ovacome must benefit the charity directly. If you wish to collect money for other charities alongside Ovacome we ask that you clearly state which charities the donations will be going to and how they will be divided. It is very important that donors know exactly where there money is going.

Branding

Please use Ovacome branded materials at your event. We can send you T-shirts (max. 3 per fundraiser), ribbons, balloons and our logo. When using the logo please ensure it is stated that the event is 'in aid' of and not 'on behalf' of Ovacome.

Entertainment

If you plan to hold an event that includes live music, dancing or a disco you will need a temporary event notice that is available from the licensing department of the local authority. You should double check with the venue provider as they may already have suitable insurance for you event.

Raffles, Lotteries & Prize Draws

Activities such as raffles, lotteries and prize draws, where a winner is chosen by chance, are governed by gambling legislation. These activities are permitted when they take place at a fundraising event and the winner is announced at the event, otherwise a licence may be required. The money made from raffles can cover the expense of the event being held. We have lots more information available on these activities so please contact us if you have any more questions.

Alcohol

If you are planning to sell alcohol at the event you need to contact the local authority's licensing department for a temporary event notice as soon as possible. If your event is taking place in a licensed premise where the bar is being run by the licensee you do not need a license.

Insurance

Ovacome cannot accept responsibility for any loss, damage or injury at a fundraising event. The charity's insurance policies do not cover property or personal liability for any injury suffered by yourself or anyone else as a result of your fundraising. Please insure that you are suitably covered for any loss damage or injury.



Collection Guidelines

On Private Property

For example a shop, pub or supermarket.

Ask the owner's permission in advance.

Leave plenty of time in case the person you ask has to check with someone else.

On Public Property

For example a park, street or square.

To collect on public property you will need a permit. You can get one from your local council. To get started, google "public collections permit" alongside the name of your local council/ the council of the area you'd like to collect in. Procuring a licence can take a few weeks or even a few months, so make sure you apply with plenty of time before your collection date.

Some councils require a letter of authorization from your chosen charity, to be submitted alongside your permit application. Ovacome can send you one of these, just get in touch with us at fundraising@ovacome.org.uk.

You will also need to inform your local police about the event. It is very important that when you are fundraising, you do it in a safe and legal manner.

Opening and returning our collection tins

Please empty tins/ buckets before returning them to Ovacome.

Peel off the 'Thank You' sticker at the top. Insert a suitable lever i.e. flat-blade screwdriver, in the gap at the edge of ring plug.

 Push lever down towards the under body of the plug and lever plug upwards - resistance will be encountered but the plug will pop out. After removing the contents, press the ring plug back into hole.

Please return unwanted tins and buckets to us so they can be reused and help Ovacome save vital funds. Please return to: Ovacome, 52- 54 Featherstone Street, London, EC1Y 8RT.
